V1 Academy Tuition Agreement

Monthly Tuition Rates

Tuition at V1 Academy is based on every month that the student attends classes at V1 Academy. Because we have a year-round calendar, tuition will be due on the first day of every month, with a late fee of \$25 being assessed if not paid by the fifth day of every month. Any tuition fees that are paid by check that is not honored by their bank will be assessed a \$35 fee per item.

Tuition rates are as follows:

One Child:	\$500 per month
Second Child:	\$400 per month
Third+ Child(ren):	\$300 per month per child

Enrollment can be paid with a check, cash, or cash app (\$V1Academy). Until we are notified in writing that your child will no longer attend classes at V1 Academy, you will be responsible to pay tuition every month and no refunds (partial or full) will be issued. Once tuition has been paid in full for the year or the month, no refunds will only be given.

Any unpaid tuition balance will result in the termination of the child's enrollment and/or delay in the completion of required coursework. Report cards and/or transcripts will not be released until all accounts have been paid in full.

A non-refundable enrollment fee will be due upon enrollment per child in the amount of \$300.00 per child. This will secure your child's spot for the grade level that your child is expected to be in and will be due every year upon re-enrollment.
